- ✓ **Verification of Student Information – Required** - Please review and return. Make corrections on the enclosed form. Please note and complete the additional information the State of Illinois requires:
 - Ethnicity – this section has changed – please read carefully
 - Legal first, middle and last names (as they appear on the birth certificate)
 - Mother's maiden name
 - Birth city, state, and country
 - Please be sure to update contact information, *including a current email address*.
- ✓ **Student Fee Schedule**– Please complete and attach a check payable to LCHS or supply necessary credit card information. You may also pay most fees online. For families with more than one student attending LCHS, only one check is necessary. Additional fees for athletics and fine arts should be paid at a later date. Per State of Illinois Mandate, **Fee Waiver Applications** will be available in late July.
- ✓ **Emergency Medical Information** – One form **required** for each student.
- ✓ **Physical Form** – to be returned before school begins
- ✓ **Internet Agreement** – signature of student and parent required
- ✓ **Sex Offender Notification** (*only if this applies to a parent/guardian*)
- ✓ **Pesticide Notification - Optional**
- ✓ **Booster Club Membership & Survey – Highly Recommended**
- ✓ **FERPA** (*Family Educational Rights and Privacy Act*) Notice - for your information only
